 - The criteria to meet merchandising standards for DG Brands is at discretion of DG Brands.
4. If you would like to sell on your website, your website must be approved and include the following requirements:
 - Dreamgirl will need to be displayed as the brand under product description.
 - The website must have a good fulfillment experience, with exchange or return policy.
 - Reviews of the business will be verified.
5. We are not accepting 3rd party retailers solely for e-comm marketplaces (e.g. Amazon, eBay).
6. All addresses will be validated and no orders shall be shipped to PO Boxes or Mailing Centers (e.g. UPS/FedEx Stores).
7. All accounts will be reviewed in a timely manner; the approval process may take up to 30 days.
8. If your account is approved, you will be provided with our MAP policy; please make sure to familiarize yourself with it.
